- <u>a) Speed Watch.</u> Cllrs Wells and Green are attending a Community Speedwatch meeting at Police Headquarters in Kempston on the evening of March 19th, 2014. Speedwatch training takes place next Wednesday, March 26th.

- **b)** Council Tax Support Grant (CTSG). Brandon Lewis MP, Parliamentary Under Secretary of State DCLG, has written to the leaders of local authorities stating that it was the

Government's intention that the element of localised Council Tax Support funding allocated to the LAs, which reflects reductions in town and parish council tax bases, should be passed down to those councils. Letter in correspondence.

- <u>c) London Green Belt Council (LGBC): Notes 166-January 2014.</u> Cllr Green has received a letter from Cedric Hoptroff of CPRE relating to Cllr Green's response to the All Party Parliamentary Group on the Green Belt. In correspondence.
- <u>d) Accident; Junction C193/A5</u>. The clerk has contacted Cllr Shadbolt, Chairman of Hockliffe PC. Cllr Shadbolt has informed the PC that it is still under discussion by the Highways Agency. Ongoing.
- **e)** Overgrown Leylandii are blocking the light to bungalows in St Mary's Close. Cllr Osborn has spoken to the owners of the trees who have said they are willing to cut them back a little bit. Ongoing.

- g) Scots Pine: Hockliffe Road. The Tree and Landscape Officer has confirmed that the tree is covered by Town and Country Planning Act 1990 section 211 because it is in a conservation area.

10. TEBWORTH POND

Cllr Hampson had a site meeting on Friday, February 21^{st,} 2014 with a representative from AES Europe, a company specialising in pond clearance. She briefly explained the proposals put forward by the representative as follows:

- i. Take samples of silt for analysis-cost = £200 approximately
- ii. Result of analysis will determine the cost of removing the silt, cheapest being nonhazardous, most expensive hazardous
- iii. The company has given a rough estimate of £15,000 to carry out all the work to the pond. This includes cutting back some of the trees
- iv. One application of Siltex. Further maintenance can be carried out by residents

Cllr Hampson will contact alternative contractors for more quotes. Once received and a decision made as how to proceed, grants will be applied for. Members thanked Cllr Hampson for all her hard work. Cllr Parry said that there would probably have to be traffic lights by the pond while the work is being carried out. Ongoing. **DH**
