#### Effect of the Order:

#### To introduce a 40mph Speed Limit on the following lengths of road in Tebworth-

- 1. Toddington Road, from the northerly boundary of number 52 in a south westerly direction for approximately 205m towards Ivy farm.
- 2. Hockliffe Road from 10m in a south westerly direction from the boundary of number 22/Mulberry Lodge extending for 135m approx. in a south westerly direction.

CENTRAL BEDFORDSHIRE COUNCIL in exercise of their powers under Sections 84(1) and (2) of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other enabling powers, after consultation with the Chief Officer of Police for the County of Bedfordshire in accordance with Part III of Schedule 9 to the Act hereby direct as follows:

- Any previous Speed Limit Orders made on the lengths of road specified in the Schedule to this
  Order are hereby revoked.
- 2. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of road specified in the Schedule to this Order.
- No speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road
   Traffic Exemption (Special Forces) (Variation Amendment) Regulations 2011 when used in
   accordance with Regulation 3(5) of those Regulations.
- 4. This Order may be cited as "Central Bedfordshire Council (TODDINGTON ROAD & HOCKLIFFE ROAD, TEBWORTH) (40mph Speed Limit) Order 201\*" and shall come into operation on the xxth day of (month) 201\*.


