1. APOLOGIES FOR ABSENCE

2. MINUTES OF June 25th, 2019 MEETING

The minutes of the June 25th, 2019 meeting were approved and signed as correct by the chairman.

- **b) PC James Bonney** is the Beat Officer for Chalgrave, Toddington and Chalton. A discussion followed after PC Bonney had introduced himself.
 - i. <u>Fly Tipping.</u> Cllr Parry said one big problem for us was fly tipping. The top of Tebworth Road is a regular spot, the most recent incident being a large load of green waste dumped on the road itself. CCTV was discussed and PC Bonney suggested installing a dummy camera. Cllr Green asked if there was a police initiative to stop fly tipping. PC Bonney replied that the police can stop a vehicle to see if the driver has a waste drop licence but instances of apprehending potential fly tippers are few and far between.
 - ii. <u>Suspicious Parked Cars.</u> Cllr Parry mentioned cars regularly parked in the gateway to the Memorial Hall. PC Bonney said he would have a look when he leaves the meeting.
 - iii. <u>Parked Cars; Junction Wingfield Road/Toddington Road.</u> Cllr Masters asked if the police can do anything to alleviate the continuing problem at this junction. PC Bonney said they can give advice but cannot prosecute.

5. REPORT FROM WARD COUNCILLOR VERSALLION

a) Queen's Head. Cllr Versallion said that CBC needs a revised application for Asset of Community Value (ACV) status for the garden which gives better evidence of events organised by the community using the garden, not by the pub. CBC excluded the garden from the ACV, which was awarded in December 2018 following a request from the property owner who described the garden as overgrown and not actively used. In answer to a question he added that CBC has to follow government guidelines regarding awarding ACVs. Cllr Green proposed, seconded by Cllr Day that a letter is written to Andrew Selous MP asking if it is government policy to give

property owners the benefit of the doubt regarding applications for ACV status. **All agreed.** Cllr Green will draft the letter. **KG; Clerk**

- b) <u>A5 through Hockliffe.</u> Hopefully the A5 will be de-trunked through Hockliffe subject to traffic being routed along the A505. There would need to be a consultation and it could take between 18 months to two years to come into effect. In the meantime traffic calming measures are planned to be installed in Hockliffe this September.
- c) <u>A5-M1 Link Road/B5120 Roundabout.</u> Cllr Versallion has asked Highways England to have a site meeting with him and a parish council member regarding the lane markings.
- **d)** Local Plan. On June 21st, 2019 both Cllr Versallion and Andrew Selous MP spoke at the CBC Local Plan Public Examination, which has been held between May and July 2019. They spoke about Gypsy and Traveller sites in particular. The Inspector has queried a number of assumptions in the Plan and he will suggest making amendments. The Plan will probably be adopted given significant amendments. If it is not adopted developers will have carte blanche. There will be another consultation around September 2019.

6. CHURCH REPORT

- a) <u>Peter Freeman</u>, the organist and organiser of events for the church, died on April 1st, 2019. His funeral service was held on June 17th and was very well attended.
- b) <u>Organists.</u> Sunday morning services are currently covered by a rota of organists. The services are now at 9.15am as some of the organists have later commitments. Services are covered more or less until the end of December but some Christmas services still need covering.
- c) Routine Tasks like cleaning the church and changing alter frontals are now being prepared on a rota basis.
- **d)** <u>Toilet Installation</u> is almost complete. Unfortunately work on the new upstairs cupboards has been delayed as the carpenter's workshop was destroyed in a recent fire.
- e) <u>Events.</u> The July cream tea was cancelled because of the continuing restoration work. A September event is planned by which time work will be complete. Several baptisms have been requested for later this year and three weddings for next year.
- f) Attendances are increasing on Sunday mornings, with 32 people last week.
- **Alpha Course.** Between 12 and 17 people attend. The last session will be held this Thursday at Chalgrave Memorial Hall. There will be two follow on sessions in August. Plans are underway for a follow on Bible Study course or home group.

- a) Stealthcam/CCTV Sign. Cllr Ludgate has put the sign up on Tebworth Road.
- b) <u>Swift Boxes.</u> The PC has asked the church if some Swift Boxes could be installed at Chalgrave Churchyard. Clerk to contact the church warden again. <u>Clerk</u>
- c) <u>Tebworth Pond.</u> Land Registry has confirmed that the PC's application for ownership is being processed. Barbara Jackson will contact the Wildlife Trust regarding the best way to clear the pondweed. BJ
- **d)** <u>Millennium Award</u>. Cllrs Parry and Warburton have contacted the local schools to inform them of the award and to ask if they can suggest any suitable candidates who live in the parish.
