7. MATTERS ARISING FROM OCTOBER 15th, 2019 MINUTES

- a) <u>Fly Tipping.</u> The PC has another CCTV sign which needs putting up by the gulley on Chalgrave Road as fly tipping frequently occurs there. Cllr Ludgate will investigate a suitable site. Ongoing. Cllr Green suggested installing a dummy camera. Clerk to find out if there are any legal requirements.
- b) <u>A5-M1 Link Road/B5120 Roundabout.</u> Cllr Versallion has been trying to arrange a site meeting with Highways England (HE) The Parish Council has written to HE to find out what progress has been made about altering the lane markings. Ongoing.
- c) <u>Swift Boxes.</u>
 - i. St Albans Diocese has an Environment Policy which includes installing nest boxes in churchyards. The diocese and the PCC would have to give permission to install swift boxes as there could be concern over the fabric of the building. The clerk will send a letter to Rev. Washington to inform her of this policy.

- ii. Cllr Green has asked the Memorial Hall Committee if boxes could be put up at the hall and the committee has agreed. The clerk will look into the procedure for installation.
- d) <u>Litter.</u> Cllr Green reported that about 30 empty vodka bottles were littered along the right-hand side grass verge of Chalgrave Road heading towards Toddington.
- e) London Green Belt Council: Press Release on Green Belt and Climate Change. Clerk to follow up on the PC's letter to CBC asking for their view on the press release. Clerk
- f) <u>BATPC AGM.</u> Cllr Parry attended the AGM held in October 2019 and the expansion of Luton Airport was discussed. BATPC has raised the noise issue with LLA/NATS/CCA. It is hoped that aircraft will vary their routes in and out of the airport so that noise does not impact one confined route.
