1. APOLOGIES FOR ABSENCE

None.

2. MINUTES OF JANUARY 19TH, 2021 MEETING

The minutes of the January 19th, 2020 meeting were approved and signed as correct by the chairman.

3. SPECIFIC DECLARATIONS OF INTEREST

- i. Cllrs Parry and Levy declared a prejudicial interest-Chalgrave Sports Club
- ii. Cllrs Day and Masters are on the editorial team of The Chalgrave News.

4. REPORT FROM WARD COUNCILLOR VERSALLION

- a) <u>Lords Hill Roundabout.</u> There has been no update from Highways England yet about the lane re-marking ongoing.
- b) <u>CBC Budget</u>. The Executive Committee has proposed a 5% increase in Council Tax, 3% of which is for adult social care. This equates to a £1.40 per week increase for a Band D property. Bedfordshire Police are proposing a 7% increase. This will help to fund 153 new officers.
- c) <u>Local Plan</u>. The Local Plan is nearing adoption. The Inspector has recently sent an update resulting in CBC dropping three potential sites in Hockliffe. One remains for 41 new homes by Hockliffe Lower School.
- d) Chalgrave Manor Solar Farm. There is no update yet. The Tilsworth solar farm application is ongoing. There is a possibility that an application for another solar farm comprising 105 acres west of the A5 may be submitted. The large concentration of applications in this area is due to the proximity of the Sundon substation. Although Cllr Versallion favours panels and wind turbines for green energy he questions taking up 105 acres in the Green Belt when they could be found elsewhere. Cllr Day commented on the piecemeal nature of potential locations for solar farms and suggested that CBC needed an overall policy. Cllr Versallion replied that he had asked for this but it was too late for a plan now and also the county is desperate for green power.
- e) <u>Hockliffe Road Speed Sign.</u> Cllr Versallion said he would follow up on a replacement speed sign on the PC's behalf.

5. CHALGRAVE CHURCH REPORT-The Rev Linda Washington

The church remains closed for services and private prayer. Services are available online and via Zoom. There have been a few funeral services.

6. OPEN FORUM

Cllrs Parry and Levy declared a prejudicial interest. Cllr Parry is Chairman of Chalgrave Sports Club. Cllr Levy is the secretary of the club.

Mr Paul Levy attended the meeting on behalf of Chalgrave Sports Club. He asked that his presentation and any points arising were minuted. He began his presentation by saying that cricket has been played in the parish for a century. He was here to inform the members that the landlord of the sports ground has terminated Chalgrave Sports Club's lease of the field. The Club has offered to buy the field but the landlord does not want to sell. He has asked the Sports Club to vacate and remove all the assets from the grounds. The landlord has agreed to allow 90 days after the end of lockdown for the committee members to remove the assets.

As yet the future of the Sports Club is uncertain but the committee is continuing to seek alternatives. The committee is hoping that someone, who does not yet know of the situation, will come forward to offer a piece of land that may be suitable. If an alternative cannot be found within the parish the committee will consider other venues outside of the parish or become a wandering side. Mr Levy said that the Club hoped to continue as a service to the community.

When Cllr Green asked the reasons for the termination Mr Levy said that the landlord had the right to do what he liked with his land.

Cllr Green said he knew the landowner had concerns about how few cricket matches had been played in recent years. Mr Levy advised everyone was concerned and a plan to rejuvenate the club had been started. Mr Levy responded that he did not know of any such concerns but also pointed out that these had not been mentioned previously.

Cllr Masters said the loss of the sports club would be a tragedy for the village and would it be possible to relocate cricket games to the Memorial Hall grounds? She was informed there was not sufficient space there. Cllr Masters also asked if the assets such as club house or storage unit might be relocated to the Memorial Hall grounds where they could continue to be used by the village and was informed by Cllr Parry this was something that had already been discussed by the sports club members.

Cllr Masters asked what would happen to the £10,000 grant that the Club had received from CBC some months ago if the Club was liquidated. Mr Levy said he would hope to sell the assets and return the grant to CBC. However, the Club recently had to spend £2,700 to repair the gang mowers in order to cut the grass.

Mr Levy thanked the Parish Council for its support of the club over the years.

- i. A mains water pipe next to Ivy Farm burst during the recent very cold weather. The water fed straight into the pond causing it to overflow. This could hinder planting. The PC agreed to contact Anglian Water to ask whether the mains water will affect the ecology of the pond.

- ii. Cllr Day has ordered hedging and plants for the pond and surrounding area. The cost is £126.00. She has volunteered to look after them for a while until they can be planted. She also said she will be looking for volunteers to help with the planting subject to current COVID-19 guidelines. Progressing.
